Motion by Holz and seconded by Stark to adopt and approve the 2019-2020 Budget for Niobrara Public Schools as published. RCV: Stark-aye, Kemp-aye, Adema-aye, Moody-aye, Holz-aye, Klug-aye. Motion Carried.

Motion by Kemp and seconded by Stark to adopt and approve the tax levy rate at General Fund \$.934367 and Special Building Fund \$.020245 for Niobrara Public

Schools District 54-0501 for the 2019-2020 school year. RCV: Kemp-aye, Adema-aye, Moody-aye, Holz-aye, Klug-aye Stark-aye. Motion Carried.

## RESOLUTION

**WHEREAS**, the Board of Education of Niobrara Public School District No. 1R a/k/a Niobrara Public Schools is obligated to pay ongoing expenses and increasing expenditures to operate the school district; and

**WHEREAS**, the Board has determined that it needs to collect more property taxes than it collected in the prior year; and

**WHEREAS**, on September 9, 2019, the Board published notice in a newspaper of general circulation; and

**WHEREAS**, said notice was published at least five days prior to the Board's special meeting; and

**WHEREAS**, said notice included the required items as specific in Neb. Rev. Stat. § 77-1601.02;

**NOW, THEREOFRE, BE IT RESOLVED** by the Board of Education of Niobrara School District No. 1R a/k/a Niobrara Public Schools that the Board has considered and approved the property tax request for the following year, as follows:

1. The amount of the property tax request is \$1818181.80

2. The total assessed value of property differs from last year's total assessed value by 1 % percent;

3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.934367 per \$100 of assessed value;

4. The Niobrara Public School District proposes to adopt a property tax request that will cause its tax rate to be \$.934367 per \$100 of assessed value;

5. Based on the proposed property tax request and changes in other revenue, the total operating budget of Niobrara Public School will exceed last years by -1% percent.

The foregoing Resolution having been read in its entirety; Member Brian Stark moved for its passage and adoption. Member Leon Klug seconded same. After discussion and on roll call vote the following members voted in favor of passage and adoption of the above Resolution:

#### RESOLUTION CALLING LIMITED TAX GENERAL OBLIGATION REFUNDING SCHOOL NOTES, SERIES 2016, DATE OF ORIGINAL ISSUE – SEPTEMBER 30, 2016, FOR REDEMPTION PRIOR TO MATURITY

"BE IT RESOLVED by the Board of Education of Knox County School District 0501, in the State of Nebraska, as follows:

Section 1. That a portion of the following outstanding notes of the School District are hereby called for redemption on October 15, 2019:

Limited Tax General Obligation Refunding School Notes, Series 2016, date of original issue – September 30, 2016, in the principal amount of One Million Seven Hundred Ten Thousand Dollars, (\$1,710,000), becoming due and bearing interest as follows:

Maturing December 15:	Principal Amount:	Interest Rate:	CUSIP

Said portion of notes are hereinafter referred to as the "Redeemed Notes."

Said Redeemed Notes are subject to redemption at any time on or after December 15, 2018, at par plus accrued interest to the date fixed for redemption. Said notes were issued by the District (1) to pay, together with available funds of the District, the District's outstanding Limited Tax General Obligation Refunding School Notes, Series 2013, dated September 24, 2013, and (2) to pay issuance costs of the Redeemed Notes.

Section 2. Said notes shall be presented for payment at the office of BOKF, National Association, in Lincoln, Nebraska as Paying Agent and Registrar (the "Paying Agent") of the Redeemed Notes.

Section 3. A copy of this resolution shall be filed immediately with the Paying Agent, not less than thirty days prior to said date fixed for redemption. The Paying Agent is hereby directed to mail notice to all registered owners of the Notes to be redeemed not less than thirty days prior to the date fixed for redemption in accordance with their authorizing resolution and to take all other actions deemed necessary in connection therewith.
